### **PROVISIONAL ELIGIBILITY STATUS OF CANDIDATES FOR RECRUITMENT TO FACULTY (GROUP-A) POST OF ASSISTANT PROFESSOR ON CONTRACT BASIS AT AIIMS RAIPUR**

1. This is with reference to recruitment advertisement No. RC/F-R/2/2024, dated 15.03.2024 regarding recruitment to various faculty (Group- A) posts of Assistant Professor on Contract basis in various departments at AIIMS Raipur.

5. Candidate should also send their claim objection through **Speed Post/ Registered Post** to the address given below. The envelope should be super-scribed "Claim Objection for the Post of ..... 6. The claim/objection/representation submitted by the candidates will be scrutinized by the Scrutiny Committee and subsequently final eligibility status of candidates will be published on the website of AIIMS Raipur.
