- 1. This is with reference to recruitment advertisement No. RC/F-R/2/2024, dated 15.03.2024 regarding recruitment to various faculty posts on direct recruitment basis in various departments at AIIMS Raipur.
- 2. - 5. Call letter for interview to all 'Eligible' and 'Provisionally Eligible' candidates will be separately sent by email only.
- 6. In case of selection, Technical resignation and benefit of past service will not be admissible.
- 7. No TA/DA shall be provided for attending the interview.
- 8. Candidates working in Central/State/UT Government Organizations/PSUs/Autonomous Bodies <u>must</u> submit NOC from their current employer stating to permit them to get relieved, in case of selection.
- 9. Candidature of the candidate is purely provisional and it will be under subject to fulfilment of all the eligibility criteria mentioned in the advertisement, failing which candidate will not be allowed to appear for interview under any circumstances.
