With respect to post of **Executive Engineer (Electrical), Assistant Engineering (Civil), Assistant Engineering (Electrical), Assistant Engineering (A/C&R) and Assistant Engineering for Vigilance Cell (Civil)**, the eligibility of candidates has been determined on the basis of information provided in the online application form and documents submitted by them in respect of prescribed essential qualification and experience for the post which has been scrutinized by a duly constituted Scrutiny Committee at AIIMS Raipur. Accordingly, an eligibility list of candidates applied for these posts is prepared and appended at **Annexure-2**.
5. With respect to posts mentioned in **para 4**, if any 'Provisionally Eligible' or 'Ineligible' candidate has any claim/objection on his/her eligibility, he/she is required to submit the same with all supporting documents **(in single PDF file)** through email only to recruitment@aiimsraipur.edu.in within **02 (Two) days** from the publication of this notice.
