## NOTICE

### PROVISIONAL ELIGIBILITY STATUS OF CANDIDATES AND TENTATIVE INTERVIEW SCHEDULE FOR RECRUITMENT TO FACULTY POSTS AT AIIMS RAIPUR (PHASE-V)

1. This is with reference to recruitment advertisement No. Rec.Cell/F-R/2021/406 dated 02.11.2021 regarding recruitment to various faculty posts on direct recruitment/ deputation/contract basis/retired faculty in various departments at AIIMS Raipur.
2. In view of large number of applications, the above-mentioned recruitment process is being done in a phased manner. Accordingly, interviews for the following departments will be conducted in Phase-V as per the following schedule:-

3. Scrutiny of applications and documents submitted by candidates was carried out by the Scrutiny Committee. Based on the same, a list of 'eligible', 'provisionally eligible' and 'ineligible' candidates has been prepared and is placed at **Annexure-I**.
4. Final eligibility list for the department of General Surgery and Trauma and Emergency (General Surgery) has already been published on the website of AIIMS, Raipur vide Notice No. Rec.Cell/F-R/2021/11 dated 08.04.2022.
5. If any 'Ineligible' or 'Provisionally Eligible' candidate has objection/clarification regarding his/her eligibility status, he/she may send claim/representation in support of his/her eligibility for the post along with the scanned copies of **relevant supporting documents** by email to **recruitment@aiimsraipur.edu.in** by **21.09.2022**. In case of multiple pages of supporting documents, candidates should make **one single (merged) pdf file** of all relevant supporting documents and send the same as a single 'attachment'.
6. For prompt classification of email and also to avoid routing to spam folder, candidates should keep the **subject line of the email** as under:-

**"Claim in support of eligibility for Faculty post – Application No. ...."**

7. Such candidates may also submit their claim/objection/ representation along with self-attested copy all supporting documents in person latest by **21.09.2022** between 11:00 AM to 5:00 PM (on working days) to Recruitment Cell, AIIMS Raipur. However, no TA/DA shall be payable to such candidates in this regard.
8. Any claim/objection/representation regarding eligibility status received after the prescribed date will not be entertained.
9. The claim/objection/representation submitted by the candidates will be scrutinized by the Scrutiny Committee and subsequently final eligibility status of candidates will be published on the website of AIIMS Raipur in due course.
10. Call letter for interview to all 'Eligible' and 'Provisionally Eligible' candidates will be sent separately by email only with the publication of final eligibility status.
11. Candidates are advised to regularly visit the website of AIIMS Raipur ([www.aiimsraipur.edu.in](http://www.aiimsraipur.edu.in)) for further updates of the recruitment process. They should also check their registered e-mail ID (including spam folder) for updates.

**Note:**

1. Candidates who have applied online in the stipulated time but whose hard copy of applications received after the prescribed date are also considered for scrutiny/further recruitment process.
2. No application has been received against EWS category posts in the above mentioned advertisement. As per the Govt of India rules/DoPT OM dated 31.01.2019, vacancy earmarked for EWS will not be carried forward as backlog to the next recruitment year. Hence, eligible candidates from other category i.e. UR/OBC/SC/ST have been considered in scrutiny for such post as a UR candidate.
3. As per point 3 of Section 8 (General Conditions) on page 9 of the advertisement dated 02.11.2021, candidates working in Central/ State Govt. Organizations/ PSUs/Autonomous Bodies have to **mandatorily produce NOC** at the time of interview. Such candidates may not be allowed to attend interview without NOC.
4. Appointment on permanent basis to the post of Associate Professor in the Dept. of Paediatric Surgery will be as per the decision of the Hon'ble CAT, Jabalpur which may be expected in its next hearing.
