The objections/clarifications submitted by the candidates will be scrutinized by the Scrutiny Committee and subsequently final list of selected candidates will be prepared and accordingly final result will be declared.

Candidates should note that their candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfill any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.

After declaration of final result and before joining of the candidate in the institute, all certificates which are provided by the candidate may be sent for the police verification and if the same found **fake/tempered/false, candidature of the candidate will be cancelled also the legal action will be taken against the candidate and issuing authority of the certificates.**
