



**NOTICE REGARDING RECRUITMENT OF VARIOUS GROUP 'B' AND GROUP 'C' POSTS ON DIRECT RECRUITMENT BASIS IN AIIMS, RAIPUR**

Reference is invited to the advertisement No. Admin/Rec./Regular/Group 'B'/12/2017/AIIMS.RPR/2155 and No. Admin/Rec./Regular/Group 'C'/10/2017/AIIMS.RPR/2156, dated 06.12.2017, inviting online applications for recruitment of various Group 'B' and Group 'C' posts on Direct Recruitment Basis in AIIMS, Raipur.

Computer Based Test (CBT) was conducted on 27<sup>th</sup> and 28<sup>th</sup> February 2018 for recruitment to the posts of **Medical Record Officer, Physiotherapist (Multi Rehabilitation Worker) and Junior Warden (House Keepers)** on Direct Recruitment Basis in AIIMS, Raipur. The result of CBT for above said posts were vide Notice No. 5/3/2018-Rectt. AIIMS.Rpr dated 08.08.2018 and No. 5/4/2018-Rectt.AIIMS.Rpr, dated 10.08.2018. Document verification of shortlisted candidates was held from 30.08.2018 to 01.09.2018 in the premises of AIIMS Raipur.

After the preliminary document scrutiny some objections were raised by the candidates. In this regard, a Scrutiny Committee was constituted for the post of Medical Record Officer, Physiotherapist (Multi Rehabilitation Worker) and Junior Warden (House Keepers). The Committee thoroughly re-scrutinized the applications of all shortlisted candidates.

The list of eligible, provisionally eligible and in-eligible candidates for the above mentioned post has been prepared and appended below. If any provisionally eligible, in-eligible candidate has any objection/ clarification regarding his/her eligibility, he/she may send their objection/ clarification along with relevant documents to [recruitment@aiimsraipur.edu.in](mailto:recruitment@aiimsraipur.edu.in) and subsequently send the same by speed post /registered post to Sr. Administrative Officer, AIIMS, Tatibandh, Raipur (C.G.) Pin 492099, which should reach the above said address by **28-01-2019**. The objections/clarifications received after 05:00 PM on **28-01-2019** will not be entertained.

The candidates may also report personally along with all supporting documents (in original and a self attested copy of these documents) in favour of their candidature from 18-01-2019 to 28-01-2019 between 11:00 AM to 5:00 PM (on working days) to Sr. Administrative Officer, AIIMS Raipur, Tatibandh, Raipur. No TA/DA shall be provided for this purpose.

The objections/clarifications submitted by the candidates will be scrutinized by the Scrutiny Committee. Only those candidates who are found to be eligible will be considered for final selection.
