AIIMS Bhopal is a premier Institute of National Importance (INI) established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) with the aim of correcting regional imbalances in quality tertiary level healthcare in the country and attaining self-sufficiency in graduate and post graduate medical education and training.

The Director, AIIMS Bhopal invites applications in the prescribed pro-forma from eligible Officers of Central/State Government/U.T/Autonomous Bodies/ Universities/ Public Sector Undertaking/R&D Organization/Police Departments of Central/State/U.T for filling up of one **Group 'A' post of Medical Superintendent in the pay Matrix/Level-14** as per 7<sup>th</sup> CPC (Rs 144200-218200) + NPA on Deputation Basis (including short term contract) at All India Institute of Medical Sciences, Bhopal. The essential qualification, experience and other eligibility conditions etc. required for applying for the post are as under:-

#### **Essential Qualifications & Experience**

- A Medical qualification included in the I or II Schedule or Part II of the third Schedule to the Indian Medical Council Act of 1956 (persons possessing qualifications included in part II or third schedule should also fulfill the conditions specified in Section 13(3) of the Act.
- 2. A Postgraduate qualification, e.g. MD or MS or a recognized qualification equivalent thereto

Or

M.H.A. (Masters in Hospital Administration) or a Post Graduate Degree recognized as equivalent to M.H.A. by the Medical Council of India.

#### Experience:

Ten years' experience in Hospital Administration in Hospitals after obtaining the P.G. Degree in a senior position, preferably in hospitals with 300 beds

#### Maximum Age Limit:

Maximum age limit for applying for the aforesaid post on deputation is 56 years as on the last date of receipt of applications

#### Other information for the candidates

- The period of deputation will be for a period of three (3) years and extendable for a maximum period of seven years as per DoPT guidelines.

- Vigilance Clearance will not normally be granted for a period of 3 years after the currency of punishment, if a minor penalty has been imposed on an officer. In case of imposition of a major penalty, Vigilance Clearance will not normally be granted for a period of 5 years after the currency of punishment in terms of DOPT&T O.M. No.11012/11/2007-Estt(A) DATED 14.12.2007.
- 2. While forwarding applications in respect of officers who are about to complete their 'cooling-off' period shortly the instructions of DOP&T as contained in O.M. No.2/1/2012-Estt.(Pay.II) dated 04.01.2013 may be strictly adhered to.
