AIIMS Raipur is an apex healthcare institute, established by the Ministry of Health and Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY) with the aim of correcting regional imbalances in quality tertiary level healthcare in the country and attaining self-sufficiency in graduate and postgraduate medical education and training.

- 1. Age and all other qualifications will be counted as on last date of application.
- 2. The above vacancies are provisional and subject to variation. The Director, AIIMS, Raipur reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements of the Institute.
- 3. The reservation and relaxation applicable to various categories will be admissible as per the Govt. of India Rules on production of valid caste/category certificate in the prescribed format.
- 4. The reservation for ST/SC/OBC/EWS candidates is as per Central Govt. rules and 4% reservation for PwBD candidates (on horizontal basis). For OBC Candidate, candidates must attach certificate valid for the posts under the Central Government of India which mentions that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should be in the vacancy year. For SC, ST and OBC, Certificate should be issued by Tehsildar or above rank authorities prescribed by the Govt. of India in the format prescribed by the Central Govt.
- 5. For posts reserved for OBC category, OBC-NCL candidates' eligibility will be based on the castes borne in the Central List of Govt of India. The OBC candidates applying for the vacancies reserved for them against this advertisement must produce OBC (Non-Creamy Layer) certificate based on the income for the Financial Year (FY) 2024-25.
- 6. EWS candidates must have a valid EWS certificate valid for the year 2024-25 in the prescribed format (given in the DoPT O.M. dated 31.01.2019).
- 7. Reservation/relaxation to Person with Benchmark Disabilities (PwBD) will be admissible in accordance with the RPwD Act, 2016 and the Ministry of Social Justice and Empowerment, Govt. of India, Notification No. 38-16/2020-DD-III dated 04.01.2021 as amended from time to time on submission of valid Disability Certificate. The Institute may verify the authenticity of the certificate of disability and examine suitability of the candidate in terms of functional requirements before appointment against any identified post. In this regard, the decision of Competent Authority at AIIMS Raipur will be final.

- 8. Ex-servicemen/Commissioned Officers seeking age relaxation shall be required to produce Discharge Book / documents issued by the competent authority in support of their category.
- 9. As per the Govt. of India rules, EWS posts will not be carried forward to next year as backlog vacancy in case unfilled. Hence, other category candidates (i.e. UR/OBC/SC/ST) are allowed provisionally to apply for such posts subject to condition that they will be considered for such post as a UR Candidate.

Scheme of Selection

Final selection for Medical Physicist and Nuclear Medicine Technologists may be carried out based solely on the interview if the number of eligible candidates remains below the specified threshold. A screening test in MCQ based written examination may be conducted to shortlist the eligible candidates for the interview if number of applications received in a sufficiently large number, if required. The details of such examination will be updated on the website in due course.

Terms & Conditions for Appointment on contract basis at AIIMS Raipur

- 1. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- 2. Canvassing of any kind will lead to disqualification.
- 3. The appointment is purely on contract basis for a period of 11 (eleven) months or till such time an alternate arrangement is made, whichever is earlier, with effect from the date of joining. As per the requirement of the Institute, the period of contract may be extended for another term or for a specified period, whichever is less, subject to satisfactory performance of the incumbents and approval of the competent authority. If the contract is not extended further, the same will lapse automatically.
- 4. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority.
- 5. The appointee shall be on the whole time appointment of the AIIMS Raipur and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
- 6. The appointee is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
- 7. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
