It is the sole responsibility of the candidate to track for the application and the undersigned is not responsible for any postal delay. The candidate needs to submit the application form as per the format. No change in serial no. order and the heading of the column to be made. Annexure may be added as separate sheets if required.

Terms and conditions

1. The above-mentioned vacancy is for a fixed tenure of 06 months and extendable up to 09 months depending on the satisfactory performance and budget allocation from State Planning Commission, Chhattisgarh.
2. The selection will not be an employment on AIIMS Raipur pay-roll. Employment will automatically get terminated upon completion of the 06 months from the day of joining of duties and there is no liability for permanent employment on AIIMS, Raipur or on Principal investigator. The candidate will have NO right to claim permanent employment under AIIMS/State Planning Commission or continuation of his/her services in any other project.
3. Mere fulfilling the essential qualification does not guarantee the selection.
4. Incomplete applications or applications without prescribed format or received after due date will not be considered. Last date of receipt of application is **20/11/2025 till (05:00 PM)**. The application will not be accepted through any other means.
5. The competent authority will have full right to adopt short listing criteria i.e. written test/Experience/Educational qualification or any other means for short listing the candidates. The applications received will be scrutinized and the list of shortlisted candidates for interview/test will be published on the website.
6. In case of large number of applications, the interview may be spilled over to the next day or a screening/written test may be held, or any other criteria may be adopted as may be deemed fit to shortlist the candidates. The decision of the competent authority in this regard will be final and no correspondence whatsoever will be entertained in this connection.
7. Selection will be made on the basis of performance in interview/written test or as decided by the competent authority.
8. If any declaration given or information furnished by him/her is found to be incorrect/false or if he/she is found to have willfully suppressed any material, or information, he/she will be liable for removal from service and also such other action as may be deemed necessary by the competent authority.
9. If any candidate is found canvassing for his/her selection, he/she will be disqualified from the selection process and other action that may be deemed necessary by the competent authority.
10. The decision of the competent authority regarding selection of candidate will be final and no representations in this regard will be entertained.
11. 13. No other/ additional allowances other than the consolidated salary mentioned will be admissible. The appointee shall not be entitled to any of the benefits available to other employees of AIIMS Raipur appointed on regular basis.
14. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
15. The appointee shall be on whole-time appointment for the project concerned and shall not accept any other assignment paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of the contract.
16. No TA will be admissible for attending the interview and for joining the duties in case of selection.
17. Records related to this recruitment will only be preserved for six months. Thereafter these shall stand destroyed except for the records of selected candidates.
18. If candidate is working in Government/Semi-Government/PSU Institution, a No-Objection Certificate from the employer is a must at the time of interview.
